I write to advise that your application has been allocated to me to review to see if it can be Duly Made.

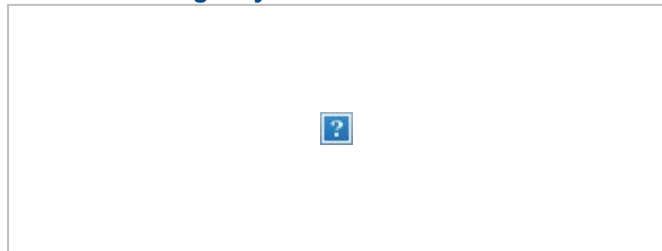
