S6 1QT, Blue Phoenix Limited: environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for Blue Phoenix Limited. Please use the reference number below when making comments on this application.

- Permit Number: EPR/ZP3492EG/V007
- Regulated facility type: An existing Incinerator Bottom Ash (IBA) permitted to accept 200 tpa of IBA.

Changes proposed include:

• Extension of the current environmental permit boundary to incorporate additional storage space (the

extension will increase the Site's maximum storage capacity at any one time from approximately 100,000

tonnes at present to 175,000 tonnes)

• Increase the permitted annual throughput at the site by 100,000tpa (increasing the sites annual

throughput to 300,000tpa)

• Addition of a second attenuation lagoon for attenuation of surface water runoff from the Site's extension

area

- Incorporate a point source discharge to sewer at SK 32263 92013 from the new attenuation lagoon
- Regulated facility location: Sheffield IBA Facility, Beeley Wood Lane, Sheffield, S6 1QT
