
2.0 Condition of the land at permit issue

The site is located on an industrial estate with properties in the immediate area being industrial and commercial in operation. The site is located in the AQMA put in place by the Royal Borough of Greenwich in relation to NO₂ and PM10:




Information in respect of the geology, hydrogeology and surface water has been evaluated using DEFRA Magic Maps.


According to the Environment Agency flood map for planning, the site is in flood zone 3 and the probability of flooding from rivers or the sea is therefore high. However, this does not take account of any protection offered by flood defences, in this case the Thames Barrier.



There is also a risk of flooding from surface waters, with the local surrounding area a patchwork of low/medium risk;




The site is considered to be medium-high on the groundwater vulnerability map, with a soluble rock risk:

We are unaware of any pollution incidents that may have taken place on this site. Prior to WWI, the local area was used as wharves and for the manufacture of cables and telegraph equipment. The immediate area was terraced housing although during the 1920's these houses were replaced by industry;



There is no visual or olfactory evidence of existing contamination on or around the site or damage to existing pollution prevention measures i.e. impermeable work surfaces.
