### 1 <u>Introduction</u>

#### **1.1** Note

- 1.1.1 This Non-Technical Summary (NTS) accompanies an application for a variation of EP3495VT/A001 which is operated by Cheshire Demolition & Excavation Contractors Limited. The Environmental Permit is situated at Moss House, 77, Moss Lane, Macclesfield, Cheshire, SK11 7TT.
- 1.1.2 The permit was originally issued on 22/10/2009 and is a SR2008No5 household, commercial and industrial waste transfer station with asbestos storage.

## 2 Application proposals

#### 2.1 <u>Variation proposals</u>

- 2.1.1 The proposed variations to this permit are clearly set out below:
  - i) To increase the permit boundary of the site
  - ii) Vary the existing standard rules SR2008 No 5 permit to a bespoke hazardous waste transfer station (Section 1.16.5 of the charging tables)
  - iii) Addition of physical treatment of non-hazardous waste (Section 1.16.13 of the charging tables)

### **Application processes**

#### 3.1 <u>Schedule 1 - Operations</u>

- 3.1.1 The EP is required for the storage prior to removal and treatment of waste.
- 3.1.2 The proposed operations to be permitted on site for the hazardous waste transfer station are shown below and no more than 75,000 tonnes of waste per annum will be accepted under this activity.:

3.1.4 The total throughput of the site will be limited to 150,000 tonnes per annum; 75,000 for the existing waste transfer station and an additional 75,000 for the aggregates recycling (physical treatment of non-hazardous waste) facility.
