### INTRODUCTION

This document provides the additional information requested by email (14 October 2022, Kirstie Lythgo) in support of the Air Quality Assessments for the Virtus London 9 and Virtus London 11 data centres, prepared by WSP (October 2022) in relation to acid deposition

Acid deposition was not reported in the Air Quality Assessments since it can readily be screened as negligible. Notwithstanding this, the impacts are quantified below.

*All impacts on acid deposition are insignificant*, as they were for nitrogen deposition. The latter were shown in Table 9-1 of the air quality assessments (70092911\_AQ02 & 70091311\_AQ01).

The data are provided for the designated sites for which critical loads for acidity are provided on APIS, and the impacts are assessed against the minimum  $CL_{max}N$  critical load.
