I understand the change is due to the volume being digested sludge being transported to the site, is now what they have based the volume on, whereas in the past I believe they were looking at the output of the process as the basis for the throughput.

The IED permitting process which has been going on across the water industry for the last couple of years has thrown up similarly large increase in throughputs due to changing how throughputs were calculated, for those sites which have undergone the Reg 61 process.
