ST13 5QG, R Bestwick and Sons Limited: environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for R Bestwick and Sons Limited. Please use the reference number below when making comments on this application.

- Permit Number: EPR/FB3934RM/V002
- Regulated facility type: Metal recycling site: the application is to update the existing mixed metals permit (including End of Life Vehicle dismantling and Waste Electronic and Electrical Equipment storage) to modern conditions, which will include up to date EWC codes, with an annual throughput of 25,000 tonnes. The application also seeks to add a Household, Commercial and Industrial waste transfer activity including physical treatment, with an annual throughput of 25,000 tonnes.
- Regulated facility location: The Scrap Yard, Barnfield Industrial Estate, Leek, Staffordshire, ST13 5QG
