Sam,

I am usually pretty sanguine about metals as the metal loading in typical landfill leachate is usually pretty low. I also failed to read the italics under the table on the first time around which didn't help!

To illustrate I have looked at the past 5 years worth of raw leachate data. I've removed the more obvious outliers from the dataset and set anything below the detection limit to the detection limit. It is also worth noting that this is the entire dataset and in practice the make-up of the raw leachate into the plant will be skewed by which areas of the site the leachate comes from, which we can also influence up to a point.

The limits below your table are italicised in the Proposed Limit column otherwise the limits come from the table (Poplars Consent). I expect that the Arsenic, Chromium and possibly Silver exceedances are due to outliers in the

dataset, whereas iron will drop out in the aeration phase of a standard treatment plant. The ones that concern me are copper and nickel which tend to be two of the metals that are elevated in leachate.

I assume that reference to the H1 tool that the EQS values have been used in the assessment. The EQS are based on bioavailable Nickel and Copper where as we test on a Total basis. So I thought it worth clarifying the situation and checking if higher limits could be applied to the consent.

Sam,

Now that I have read your email properly, I am a bit surprised by how low the metal limits are. I am usually pretty sanguine about metal limits as landfill leachates (generally) have pretty low levels of metals something to do with redox and the carbonate sulphide sludge in the drainage blanket.

I first read the table (hence my misplaced confidence) now I have read the text underneath which I presume are the proposed limits for copper, zinc, nickel and vanadium.

I note that these are due to the 'failure' of a H1 assessment. No wanting to second guess whoever has done the assessment but I unfortunately have completed many H1 assessments and know the limitations that this screening tool has. The EQS values used in the H1 are based on 'bio-available' concentrations and not the 'total' values which we typically measure. Are the limits proposed based on 'total copper' or a different measurement?

I would also note that the UKTAG have therefore developed a tool (MBAT – Metal Bioavailability Assessment Tool) for calculating a site specific EQS value for some of these substances including copper, nickel, zinc, manganese based on the pH, DOC and calcium concentrations of the waterbody. Were site specific EQS calculated for the River Sow (the receiving water). The River Quality Planning Tool also calculates the bioavailable fraction of the metals and doesn't just use Q95 flow value.

If we do move forward with a treatment plant at 100m<sup>3</sup> we are likely to have to meet the BAT-AEL set in the waste treatment BREF which are quite restrictive.

May be worth a discussion once you have found out about the Chloride limit.

I have been advised *For the concentrations you suggested the H1 assessment fails for Vanadium, Copper, Nickel and Zinc. The concentrations we could accept are Vanadium 0.2mg/l, Copper 0.05mg/l, Nickel 0.05mg/l and Zinc 0.25mg/l.*

To be able to get any movement on these concentrations we would have to undertake a river survey – I will look into the validity of this but of course this will take more time and will not necessarily change the outcome. Happy to have a catch up call to discuss.

Samantha,

My colleague Lana has passed me your contact details as someone who would be able to help with this query. I thought it best to send an email in the first instance rather than contacting you via telephone.

As you know we currently hold a TEDC to discharge contaminated surface water from the above site. Following the recent breaches in the COD limit it appears that the effluent is more variable than our initial assumptions and therefore we have increased the frequency of testing of the effluent. This will hopefully ensure that we comply with the specified limits in the future.

We are in the initial stages of considering the possibility of building a treatment plant to treat landfill leachate that is produced at the site. In order to correctly specify the plant and the treatment techniques employed it is important to understand the likely discharge parameters, therefore, I would like to discuss with you the possibility of;

- increasing the discharge volume; ideally we would like to maintain the existing consent and increase it by ~100m<sup>3</sup>
- the inclusion of different effluent streams ie treated effluent from Meece Landfill; and
- increasing level of some substances in the discharge particularly chloride and COD.

I understand that this will require an application to you setting out fully our proposals and that any advice is only provisional. However, we are at the early stages and would appreciate an indication of the limits that we will have to work to prior to a more formal approach.

I would be grateful if we could have a discussion either on the phone (number below) or onsite. I can send a teams invite if that would be easier?
