These are the Big Dutchman Erny heat exchangers, they are dry cartridge filter type and do not produce condensate.

The dirty water line from each heat exchanger into each poultry house is for the terminal cleaning during site washdown.

Have attached the manual for the heat exchanges and an amended site plan.
