TN2 3EE, SKIPAWAY LIMITED: environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for SKIPAWAY LIMITED. Please use the reference number below when making comments on this application.

- Permit Number: EPR/LB3709LG/V003
- Regulated facility type: Application to substantially vary an existing waste management permit for a Household, Commercial and Industrial Waste Transfer Station.

The proposed changes are:

The addition of a restricted Waste code EWC 19 12 12 - Mixtures of residual waste from waste management facilities mechanically treating chapter 17 and 20 wastes not containing hazardous substances only.

The addition of waste code Waste code EWC 20 03 01 - Mixed municipal waste.

An increase in the quantity of waste accepted at the site from 50,000 to 75,000 tonnes per annum.

The adding of a new physico-chemical treatment activity with the addition of a wash plant.

- Regulated facility location: Site 'b' North Farm Lane, North Farm Lane, Tunbridge Wells, TN2 3EE
