TS23 4HS, Saltholme North Power Limited: environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

- Regulated facility type: 1.1 A(1) a): 4 x 12.6 MWe spark ignition reciprocating gas engines and will operate to provide additional energy security during periods of peak electricity consumption within the UK operating under Section 1.1 Part A(1)(a) of the Environmental Permitting Regulations (EPR) for the burning of fuel in an appliance with a rated thermal input of 50 or more MW thermal.
- Regulated facility location: Saltholme North Power, Cowpen Bewley Road, Saltholme, Stockton-on-Tees, Middlesbrough, TS23 4HS
