TW19 7BQ, Harleyford Aggregates Limited: environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for Harleyford Aggregates Limited. Please use the reference number below when making comments on this application.

- Permit Number: EPR/GB3404HX/A001
- Regulated facility type: Application for quarry restoration as an inert landfill activity. Void will allow for infilling of 749,000 tonnes (470,000m³) of inert waste, with an infilling rate of 240,000 tonnes (150,000m³) per year, which is equivalent to around 800 tonnes per working day. Also includes a proposal for a water quality discharge activity associated with the landfill.
- Regulated facility location: Homers Farm Inert landfill, Short Lane, Staines-on-Thames, TW19 7BQ
