1. **Odour Management Plan** - thank you for your further guidance. Our client is content to exclude wastes with the description 'biodegradable' or with the description of compost, and hence I attach an updated version of the listing showing Chapter 19 05 waste and 20 01 08 also identified for exclusion. Can we take it that this now provides sufficient assurance to dispense with the requirement to produce an Odour Management Plan at this time?

2. **Facility type** - we shall proceed with the facility falling under the 1.16.6 code.

Dear Alan, thank you for your update.

1. **Odour Management Plan** - The list of wastes you have submitted is not acceptable as you need to omit the wastes with odour potential. I suggest that you also consider wastes with the description 'biodegradable' or with the description of compost, to have odour potential and omit these wastes, also.
2. **Facility type** - As you have pointed out, the operations could potentially fall under more than one A code. Under the old OPRA scheme, if this happened, then operators would select the highest risk banded A code for the OPRA score. But under the new charging scheme, if your activities fall under more than one charge code you add them together (for example the 1.16.6 and 1.16.12 codes mentioned in the example above). In your case, as the activities appear to fall under a 'normal' A11 HCI transfer station and the typical treatments fall under the 1.16.6 code only, the 1.16.6 code would be the appropriate

code for this application. An additional treatment that's not part of the 'normal' HCI transfer station activities would fall under 1.16.12.

I hope this information is helpful. I look forward to receiving your response on 1 April.
