WA7 4DS, Veolia ES Landfill Limited: environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for Veolia ES Landfill Limited. Please use the reference number below when making comments on this application.

- Permit Number: EPR/HB3902HZ/V003
- Regulated facility type: The site is a non-hazardous treatment facility, mostly treating wood EWC codes.

There is an increase in annual throughput (50,000 to 75,000 tonnes/annum) and storage capacity (upto

1,714 tonnes at any one time), with some changes to site layout. We will be assessing the Fire Prevention

Plan and Dust Management Plan.

• Regulated facility location: Runcorn Wood Recycling Site, Percival Lane, Runcorn, WA7 4DS
