Thank you for the additional information.

I have an additional question on the recovered water being added to the effluent system for treatment and disposal. The previous Schedule 5 response stated that the wastewater treatment plant was designed to treat condensate only for re-use as make up water and that process effluents would be recycled as part of the lean amine system. I've attached the response for reference (question 12).

Please can you confirm that the effluent produced from the CO₂ conditioning process will be recycled as part of the lean amine system as this could potentially be contaminated with amines and the existing assessment has not considered this,

Thank you for confirming that hydrogen will be utilised in the CO₂ conditioning process. As discussed, I require some additional information:

- Provide details further details on the conditioning of captured CO₂ prior to export including the use of hydrogen and any other chemicals used. The information in the supporting information document is limited.
- Provide an updated raw materials table as found in section 4.1.1 of the supporting information document to include estimated annual consumption.
- Provide details on the storage and handling arrangements for the updated raw materials and confirm these will be included in the EMS.
- Provide an updated environmental risk assessment that includes an assessment of risk from the handling and storage of hydrogen and any other chemicals identified.
