WF6 1TW, Sharpsmart Limited: environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for Sharpsmart Limited. Please use the reference number below when making comments on this application.

- Permit Number: EPR/XP3602PF/V008
- Regulated facility type: Normanton Waste Transfer and Treatment Facility the site currently houses two
 autoclave units that thermally treat (by steam sterilisation) the incoming soft clinical waste. The EP allows
 the pre-shredding, autoclaving, and compaction of waste and the associated temporary storage of waste
 pending that process. The EP includes two directly associated activities (DAAs) which are the operation of
 a steam boiler and the washing of bins. Additionally, the EP allows the storage and repackaging of nonhazardous and hazardous waste as a Waste Operation.
- Regulated facility location: Unit 1 Loscoe Close, Normanton Industrial Estate, Normanton, WF6 1TW.
