WS11 3NR, The Brock Metal Company Limited: environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

- Regulated facility type: Section 2.2 A(1)(b):Melting, including making alloys of, non-ferrous metals, including recovered products and the operation of non-ferrous metal foundries where-
 - (i) the plant has a melting capacity of more than 4 tonnes per day for lead or cadmium or 20 tonnes per day for all other metals, and
 - (ii) any furnace (other than a vacuum furnace), bath or other holding vessel used in the plant for the melting has a design holding capacity of 5 or more tonne. [Zinc alloy production]
- Regulated facility location: The Brock Metal Company Limited, Walsall Road, Norton Canes, Canock, WS11 3NR
