WS9 8BL, Booth Ventures Waste (Midlands) Limited: environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

- Regulated facility type: This application is a new bespoke deposit for recovery permit application. Booth

Ventures Waste (Midlands) Limited proposes to construct an access road from a new site entrance on

Stubbers Green Road down to the base of the Sandown Quarry to facilitate the subsequent restoration of

the quarry. A total of 35,000 m3 of inert waste is proposed to be used for the construction of the access

road, which will be gradually covered over as the quarry is restored to surrounding ground levels.
