1. Installation address is confirmed by the client as Moorside Farm, Brandesburton Moor, Drifffield, East Yorkshire, YO25 8EP.

Dear Lizzie,

I have now taken a high level look through the application and supporting document and need the following further information before I can duly make the application:

1. Installation address

In application form B3.5 section 2b the address listed includes 'Brandesburton Moor' but checks on our mapping system and Royal Mail state it is just Brandesburton. Please confirm which is correct i.e. the full address Moorside Farm, Brandesburton or Brandesbuton Moor, Driffield, East Yorkshire YO25 8EP.

2. Application form B3.5

Please provide a revised application form B3.5 with the following:

- a. Section 14 declaration does not contain any of the partners' names therefore is not complete. I can see you have submitted 3 x part F1 forms completed by each of the partners, but B3.5 has spaces to provide separate declaration details for up to 3 partners (for future reference you can copy the page from B3.5 to add further declarations). Please resubmit part B3.5 with the three partners' details included, and we will not include the F1s as part of the application. *Apologies if you have been advised previously to supply F1 copies, this isn't necessary for intensive farming new bespoke and variation applications because we have our own bespoke application forms B3.5 and C3.5 which includes the declaration sections etc, F1s are only used for transfer and surrender applications.*
- b. Also section 8l is ticked 'yes' for exporting manure or slurry to third parties, the technical standards submitted as part of the application confirms it all goes for spreading on land owned and managed by the operators, and the non-technical summary states that 75% is exported to a third party, with the remainder spread on operator owned and managed land so please amend accordingly (and if necessary amend the technical standards if incorrect).
- c. In addition section 10a does not include reference to Appendix 10 energy efficiency document so please add that in.
- d. Please also amend section 2b with the correct address if required following response for point 1.

3. Site drainage plan

In the contents page you have stated there is a site layout, drainage and emission points plan. The site layout plan submitted doesn't include details of drainage and emission points, please provide a site drainage and layout plan clearly showing the pathways for clean, lightly contaminated and dirty water, the location(s) of dirty water tanks and slurry/manure storage, and identification of emission points to land and water (i.e. where does the roof water and yard water drain to, e.g. soakaways, settlement ponds, drainage ditch, named watercourse).

4. Dust and bioaerosol management plan

In the application you have referenced this as Appendix 8a, but I can't find one submitted, so can you please provide this.

5. **Energy efficiency**

You have referred to Appendix 10 Energy efficiency review in your contents page submitted with the application and supporting documents, but it wasn't attached when you submitted the revised application by email on 7th September 2023, so can you please submit this.

6. **Raw materials**

Appendix 11 is also referenced in the contents page for a Waste Minimisation Plan and Raw Materials Inventory but I can't find this in the documents submitted either so please submit it.

7. **Appendix 12**

You have referenced this as Housing, Drainage and Slurry Storage Review in the contents page but again, I can't find this so please submit it.

We usually allow 10 working days as a deadline for response, which is **17/11/23**. Once I have satisfactory responses I will be able to duly make the application and arrange for it to be publicised and consulted on. Please do not hesitate to get in touch if you need to discuss any of the above points further.
