Further to our telephone call, the following amendments to documents, and outstanding information, are still required:

- 1. Non-technical summary (NTS) still needs amending to reflect the ventilation in place/proposed and to confirm the boundary will be extended. Houses 1&2 have gable end fans, houses 3&4 & A&B have gable end and roof mounted fans. The NTS still states all houses are naturally ventilated.
- 2. Dust and bioaerosol management plan a revised plan does not appear to have been submitted. You must submit a revised DMP in accordance with <u>Guidance on the reduction of particulate matter from Poultry farms</u>, to include measures to minimise dust emissions resulting from the proposals to increase bird numbers, add two additional poultry houses and store manure within the installation boundary. You will also need to include any additional sensitive receptors as a result of the proposed increase in boundary.

Note: The plan should be in a similar format to your odour and noise management plans.

3. Standby generator details – the details required do not appear to have been submitted. You must confirm the following details:

- Thermal input capacity in MWth for each standby generator.
- The total hours of testing per annum e.g. 50 hours per annum, or 1 hour maximum per week, for each standby generator.
- Whether the generators are only used for emergency power supply use, where mains power has gone
 down, for less than 500 hours per annum, including testing.
- 4. Confidentiality you have not confirmed whether or not the box in Q13 of application form Part C3.5 was ticked in error. - 6. Site boundary plan confirm in writing that there is no change to the current 2020 boundary for houses 1&2 and 3&4.
- 7. Site condition report you do not appear to have submitted a site condition report. As additional land is to be included in the installation boundary, submit a revised site condition report in accordance with the guidance Environmental permitting: H5 Site condition report GOV.UK to include the additional land to be included within the installation boundary, and the changes to the activity, including the addition of the manure store, proposed poultry houses and increase in bird numbers.

Note: I have attached an example application form for information which includes an example site condition report.

8. Technical standards document – amend the paragraph, 'In each of the three layer houses one proposed ventilation is provided by gable extraction fans. In shed 3 and proposed 4 additional ventilation is provided by roof mounted fans', to reflect the latest proposals and correct ventilation i.e 1&2 – gable end fans, 3&4 and A&B – gable end and roof mounted fans.

We cannot continue working on your application without all of the information detailed above. If you are not able to submit this by the end of today, we will have to return your application and retain 20% of the application charge to cover our costs in reviewing your application, as outlined previously.
