I don't think we can help you with which of the receptors identified in the detailed modelling refers to the Hudson's Way LNR. As I understand it the EA restrict access to location information and sites are simply labelled LWS.

As per conversation yesterday , please find enclosed final duly making questions

The only aspect to be clarified is the final screening impact on modelling. In addition the modelling fee is likely to be required but will be confirmed once ammonia assessment complete

As a matter of urgency , please provide update to ammonia assessment screening request with final split of natural/HV ventilation c/w high velocity efflux velocity.

With regard to the other questions, one of particular importance are those linked to certification /performance data for scrubber.

Overall there are several documents attached aimed to assist you (typical drainage plan, certification document (this one for a poultry farm system))
