1. About this consultation

This document explains why we are consulting and what we are consulting you on. It is designed to help you understand and comment on the variation of the composition of the Wessex Regional Flood and Coastal Committee (RFCC).

1.1. Why we're consulting

We are consulting to get feedback from all of those individuals, groups and organisations, who are affected by, or interested in, the proposed approach to the variation of the scheme of membership of the Wessex RFCC, in line with the Regional Flood and Coastal Committee Regulations (2011).

1.2. What we are consulting on

We are consulting on the variation of the composition of the Wessex RFCC as a result of local government reorganisation in Dorset. The variation process is set out in the Regional Flood and Coastal Committee (RFCC) Regulations (2011), Part 3 (9) and requires Ministerial approval.

The composition variation must be made in line with the Regional Flood and Coastal Committee Regulations (2011) and subsequently there are certain limitations when proposing a new scheme. These restrictions are outlined in Section 2.

In 2011 when the transition was made from Regional Flood Defence Committees to Regional Flood and Coastal Committees, it was confirmed that LLFA representation was a matter for individual RFCCs to propose.

The Committee agreed to a composition that included a consistent representation from all LLFAs contributing to Local Levy rather than based on either number of Band D properties or the Levy paid by each LLFA. As a result the number of LLFA members was 11.

This gave a total Committee size of 21 including the Chair, 11 LLFA members and 9 Environment Agency appointed members.

At present Poole, Bournemouth and Dorset are LLFAs. The change to 2 unitary authorities will therefore reduce the number of LLFAs by 1 from 11 to 10. If the committee composition is based on the approach taken when it was established in 2011 then the number of LLFAs reduces to 10. In order to maintain a majority of LLFA membership the number of Environment Agency appointed members would also need to reduce by 1 from 9 to 8.

This would give a Committee of 19 members including the Chair, 10 LLFA members and 8 Environment Agency appointed members.

The variation will only take effect when the new Councils come into being on 1 April 2019 or as directed by government.

1.3. We want your views

Interested parties will likely include the Wessex RFCC, Dorset Councils and Local Authorities within the Wessex Boundary, Internal Drainage Boards, Somerset Rivers Authority, Water Boards, Local Flood Groups, and members of the public.

We want to hear your thoughts on our proposed approach as outlined above. Section 2 provides more information on the background for proposing the variation. You will find the consultation questions in Section 3 of this document and information on how to respond in Section 4.

2. Background to the proposal

On 26 February 2018 Sajid Javed (former Secretary of State for Housing, Communities and Local Government) announced the decision to create 2 new unitary authorities in Dorset, replacing the existing 9 councils. The decision is subject to parliamentary approval and the new structure, aimed at saving £108m over 6 years, will come into effect in April 2019. Under the plans, Bournemouth Borough Council, Poole Borough Council and Christchurch District Council would merge, and the second council would be formed from East Dorset District Council, North Dorset District Council, Purbeck District Council, Weymouth & Portland Borough Council and West Dorset District Council.

Each authority will deliver all local government services in their respective areas including being Lead Local Flood Authorities (LLFAs) and Coast Protection Authorities (CPAs). The creation of these new authorities has implications for the composition of the Wessex Regional Flood and Coast Committee (RFCC).

The Wessex RFCC membership currently includes representation from each of Dorset County Council, Bournemouth Borough Council and Poole Borough Council. This membership was signed off by the Secretary of State in 2011. Due to the changes in Dorset, the Committee membership will need to be varied before 1 December 2018 to represent the new councils in order that a levy can be issued for the Wessex area in 2019, as per the Regional Flood and Coastal Committee Regulations 2011.

Legislative restrictions

Any variation to the composition of the committee must be made in line with the Regional Flood and Coastal Committee Regulations (2011).

These Regulations require the total number of members to be at least 11 and no more than 25 (unless approved by the Minister). There can be no more than 11 Environment Agency appointed members and the number of members appointed by a constituent authority must be at least one more than the sum of Environment Agency appointed members and the Chair.

A variation takes effect when the Environment Agency publishes a document specifying the region for which the Committee is established and the composition of the Committee.

The variation does not take effect unless the Environment Agency has consulted with interested persons for a period of not less than 6 weeks in relation to the variation to the composition of the Committee; taken account of any representations; and the varied composition has been approved by the Minister. The Minister may require a change to the proposed varied composition of a Committee before approving the varied composition.

The Environment Agency may not issue a levy to constituent authorities in a region for a financial year if the composition of the Committee for that region is varied on or after 1 December in the financial year preceding that for which the levy is issued.
