Public engagement



Throughout 2024, we have run several events and engagement activities. Here's a look back on the past year...



On Thursday 18 April, we invited the public to come and find out more about plans to better protect Guildford from flooding. We displayed maps of flood zones, shared ideas from some of the other Environment Agency schemes and had staff on hand to answer questions. It was well attended, with over 120 of you stopping by.

Throughout the summer holidays, we attended family fun sessions at Dapdune Wharf National Trust, complete with Lego 'flood defence' sets and our popular flood tank. Many families attended and children were excited to learn more about the dangers of flooding and how we might prevent it.





In the autumn, we supported the Environment Agency's flood resilience team at an event to increase flood risk awareness and help people better prepare for flooding. You may also have seen us testing our temporary defences. This is standard practice to check all of the equipment is working properly, and ensure our staff are fully trained on deploying the defences.

FLOOD ALERT

Flooding is possible Be prepared

- · Be prepared to act on your flood plan
- · Prepare a flood kit
- · Monitor water levels and flood forecast



FLOOD WARNING

Flooding is expected Immediate action required

- · Move family, pets and valuables to a safe place
- . Turn off utilities if safe to do so
- · Put flood protection equipment in place



SEVERE FLOOD WARNING

Severe flooding Danger to life

- · Stay in a safe place with a means of escape
- · Be ready to evacuate
- · Co-operate with the emergency services
