## What we have done over recent months

This temporary working platform will help support the waterfront and provide an area from which to work.

Before placing the rock bags that form the working platform, the Environment Agency undertook a fish rescue to clear fish from the area. This involved:


**Step 1**: Creating a semi-circle of clean rock in the channel to mark the footprint of the working platform.

Step 2: Installing a bubble curtain around the working platform footprint.

Step 3: Removing fish from within the working platform.

**Step 4**: Filling the de-fished platform area with rock bags.

During this rescue the following fish species were found:

### **One-way system**

We are pleased to announce our intention to temporarily remove the one-way traffic management restrictions on Kidderminster Road for the Christmas period when construction will be paused.

Severn Trent Water and its contractors have completed their work according to schedule, and Kidderminster Road will revert to two-way traffic from Friday 22 December for a temporary period.

Kidderminster Road will return to a one-way system from Tuesday 2 January to allow construction of the flood risk management scheme to continue after the Christmas break.

Traffic restrictions will remain in place on Stourport Road.


### Next steps
