This audit of groundwater monitoring was undertaken by Simon Caine and Kelly Hudson, John Whyke and Robert Couldwell were present on behalf of the operator.

The following points were noted:

- John Whyke completed the monitoring, John holds the requisite qualifications to act as technically competent manager. John confirmed he had undertaken all monitoring since CAR REF 61563/0280415.
- 2. The results of the audit are presented below:

- 3. All boreholes were secured with a lockable lid. Robert explained that concrete slabs are placed over the boreholes to reduce the risk of vandalism.
- 4. BH2 was dry, as a result of this BHa was sampled.

5. A reduction in BH depth is reported in the annual monitoring report (Report No 15748/13: January 2020). However there appears to have been a further reduction in BH depth during this round of monitoring.

Prior to the next round of groundwater monitoring please investigate this reduction and provide feedback.

- 6. During the audit Robert explained that members of the public continued to enter the permitted area. Robert explained that site security would be in place prior to the commencement of activities as discussed in CAR REF 61563/0346304.
- 7. Robert advised that BH5 was lost in October 2019, this was reported to the Environment Agency in the annual monitoring report (Report No 15748/13: January 2020). The report identifies that work will be conducted to re-instate monitoring at this location.

Prior to any work please confirm this installation will be carried out in line with the approved CQA plan for groundwater monitoring boreholes. If this is not the case you are required to submit a new CQA method statement for this installation.

Steps should be taken to reduce the risk of future damage, this could include engaging with the landowner.
