Site visit arranged to review the extent of preparatory works currently being undertaken on site and discuss in more detail the additional engineering works proposed and timescales when these are likely to commence.

Security was in place at entrance of the haul road leading from Droppingwell Road.

This was an announced routine site inspection due to Covid Restrictions. Site inspection carried out in the presence of Robert Couldwell and John Whyke.

John was currently undertaking excavations to construct attenuation lagoon on the eastern side of the site. Drainage pipework is being prepared adjacent to the compound area. This culverted drainage section being installed will ensure sufficient drainage from the compound area.

Drain 2 has been constructed on the northern and eastern perimeter of the site. An interceptor drainage ditch has also been excavated on the southern edge of Cell 1, this will intercept surface water from the area of Cell 1 once constructed.

The work being undertaken on the surface water infrastructure needs to be CQA validated, therefore it is essential CQA Engineers undertake an assessment of the works currently being undertaken in accordance with Section 4 of the Surface Water Drainage Construction Proposals and CQA Programme agreed in accordance with pre-operational condition 3. Robert clarified that CQA Engineers are due on site over then next week as they are to look at basal engineering requirements.

Work on-going extending the haul road around the site. The waste being utilised under the U1 exemption to construct this haul road are satisfactory, reminded Robert of the limitations on overall tonnage authorised by the U1 exemption.

Mobile site office and storage container has been installed on site. Wheel-wash unit has been brought onto the site, although at present this is not operational as installation is not complete.

Discussed with Robert proposals with regards BH01, it was agreed rather than decommissioning the existing borehole and installing an additional well beyond the perimeter of waste deposits, that the footprint of the landfill in proximity to BH01 will be modified so there is no longer a need to remove the borehole. This will result in a stand-off margin around BH01.

Security fencing has been installed around the surface water attenuation pond on the western side of the site.

Walked around perimeter of Phase 1 and discussed the issues with security as previously agreed security fencing will be replaced once the site becomes fully operational. Further work was carried out on securing access on the southern section of the site, but further damage has been caused to the replaced sections

Queried with Robert as to whether clarification has been sought from RMBC on reinstatement of BH05. To data this has not, I I reaffirmed that we need clarification on this aspect as soon as

possible as we proposed to undertake an Environment Agency initiated variation to formalise what has already been agreed in accordance with pre-operational conditions submissions, also formalise the approved financial provision arrangements.

No mud was evident on haul road leading to main highway at the time of entering or leaving the site.
