This was an un-announced site inspection, following a report to the Incident Communication Service of oil leaking from the Phase 1 area of the site. The inspection was carried out in the presence of Robert Couldwell and John Whyke.

A walkover of the area adjacent to the northern side of Phase 1 was completed.

There is a drainage ditch to the east of the wheel wash, which has been constructed to direct surface water to Pond 2. The TCM confirmed that the northern flank of the ditch was made up of waste, which is being used under a U1 exemption to construct the haul road. He also advised that the southern flank of the ditch was made up of topsoil, which had originated onsite, from the area where the haul road is now being developed. The topsoil had been moved in November 2020.

There were a number of dry patches of soil, across the flank made up of topsoil, which appeared to have become ochreous. In addition, there were patches of the same flank where water appeared to have moved through the soil and mixed with some of the ochreous soil, leading to some discharge which was also ochre in colour. As this is an area where there are coal measures, this suggests that the discharge was natural in origin, possibly caused by the disturbance of the soil.

Actions:

- Monitor this area regularly as further investigation may be required if the discharge increases.

There were no issues relating to dust, odour or noise and there were no deposits of mud on the road adjacent to the site.
