This Compliance Assessment Report (CAR) has been completed following an unannounced site inspection by Kelly Hudson (Regulatory Specialist).

This was an unannounced site inspection primarily to check that no waste is currently being deposited at the site.

## **Current Operations & Observations**

At the time of the inspection, there was no activity taking place on site and there were no apparent changes to the site since the previous inspection in September 2023.

The gates were locked and the entrance to the site was secure.

There were no amenity issues observed.

## **Future Regulatory Focus**

- A review of monitoring data.
- An announced site inspection to discuss current plans regarding operation and groundwater monitoring.
- A review of monitoring data is to be completed in Q3.

To ensure you correct actual or potential non-compliance we may
